i. **9/30/2021 YTD financial report**

b. **Academic Medical District Update**

The groundbreaking ceremony for the VA hospital occurred on October 15th and was well attended and covered heavily by the news media. Planning sessions are ongoing as the project moves into the design phase with demolition beginning Spring 2022. The remaining employees in the building are scheduled to vacate by the end of 2021.

Mental Health Hospital planning is nearing the end of the programming phase. A request for approval to begin the selection process for a construction manager is anticipated to come before the board in December or early 2022.

The city of Tulsa will vote on November 17th to potentially increase their financial investment in the parking garage project by \$4 million.

c. **Medically Home Update – Michael Rogers**

The October 1st milestone to produce the draft plan was met and the plan has been distributed for review. The final version is due in the Governor's Office on December 1st.

d. Legislative Update

Jessica Russell – The Special Session begins on November 15th. The special session will address the single issue of redistricting.

Jami Longacre – Update was given that former OSUMA Chair, Senator John Haste is now Vice Chairman of Public Health committee.


