# Meeting Minutes Oklahoma State University Veterinary Medicine Authority

The OSU Veterinary Medicine Authority convened a special meeting at 10:00am on Wednesday, November 15, 2023 in 115 McElroy Hall on the OSU Stillwater campus.

Notice of the meeting was provided in writing to the Oklahoma Secretary of State consistent with the open meetings guidelines and the agenda was posted at McElroy Hall prior to the meeting in compliance with the Oklahoma Open Meeting Act.

Dr. Jim Hess, CEO of the Authority, called the meeting to order at 10:00am. Roll was called and a quorum was established.

Dr. Hess introduced President Johnny Stephens. President Stephens welcomed the Authority members and expressed appreciation for their service.

#### I. Dr. Hess welcomed and introduced the Authority members.

#### II. Execution of Oath of Office

Dr. Hess asked the Authority members to sign the oath of office which fulfills the statutory requirements and affirms they will faithfully discharge their duties as a member.

# III. Election of Officers – Possible Vote for Approval of Officers for the OSU Veterinary Medicine Authority.

Chairman Arthur asked the Authority members to introduce themselves and provide some additional background.

#### IV. Discussion and Possible Vote for Approval of By-Laws for the OSU Veterinary Medicine Authority

Dr. Hess introduced Amy Newton, assistant general counsel for the OSU A&M Board of Regents. Dr. Hess acknowledged Ms. Newton for her assistance in reviewing and editing the by-laws.

Motion to approve by-laws made by Jarold Callahan, seconded by Philip Wood.

Philip Wood asked what the process is after the Authority gives approval to transfer funds and purchase equipment. Dr. Hess said there is regulatory oversight from OSU for all spending of Authority transfers.

# V. Discussion and Possible Vote for Approval of General Policies, Procedures and Standards for the OSU Veterinary Medicine Authority

Dr. Hess presented the policies and procedures for Authority approval. The document is in compliance with the Open Records Act.

## VI. Report and Overview of College of Veterinary Medicine Status – Dean Carlos Risco

Dean Risco introduced Kristy Howey, Director of Business Operations, Dr. Kelly Black, Director of Veterinary Medical Teaching Hospital, and Jeremy Douthit, Manager of Facility Services.

Dean Risco presented a power point and an overview of the College. He noted that they are currently working to update facilities and fill open faculty positions before the accreditation review in April, 2024.

#### VII. Chief Executive Officer's Report and Possible Action Items

a. Discussion and possible vote for the approval of Administrative Services and Fiscal Agreement with Oklahoma State University

Dr. Hess explained that OSU will provide support to the Authority from staff, Purchasing, IT, Marketing, etc. OSU will benefit from the support so there will be no charge to the Authority for these services. This agreement will automatically renew each year unless terminated by either party with 90 days notice.

b. Discussion and possible vote for the approval of the Accounting and Payment/Reporting Agreement with the Office of Management and Enterprise Services – State of Oklahoma and subsequent payment in the amount of \$1,000 per month.

Dr. Hess explained the Office of Management and Enterprise Services will be providing limited fiscal services for the Authority. The fee of \$1,000 per month is the requested amount for the services.

c. Discussion and possible vote for approval of the transfer of state appropriated funds to the OSU College of Veterinary Medicine for the support of costs related to the employment of existing and new faculty and staff and operational costs. Approval is requested for the transfer of \$10,327,000 in 1/12<sup>th</sup> increments as it is received by the Authority. The transfer requested for the first six months of the 2023~2024 fiscal year shall be \$5,163,500.

Dr. Hess explained the amount of \$5,163,500 is to cover the expenses for the first half of the fiscal year. Moving forward, transfers of  $1/12^{th}$  of \$10,327,000 will be made each month.

d. Discussion and possible vote for the approval of transfer of funds to the OSU College of Veterinary Medicine for payment to OSU Long Range Facilities Planning in the amount of \$300,000 for the design and management of renovations of clinical and academic facilities at the College of Veterinary Medicine.

Dr. Hess explained approval is needed to provide funds to OSU Long Range Facilities Planning so they can begin the process for design and production improvements.

Motion to approve transfer of funds in the amount of \$300,000 made by Troy Shelby, seconded by Philip Wood.

As the projects are completed and equipment purchased, the chart will be updated with actual amounts and made available to the members of the Authority.
